## **BIRD SALE RULES**

- 1. There will be no pre-selling of Birds, offenders will be asked to leave the venue.
- 2. Birds are to be benched by 9:30am Sunday or between 4pm & 7pm Saturday afternoon.
- 3. All sellers must be a member of a CCBFA affiliated club and show proof of membership.
- Overcrowding in cages will not be tolerated or permitted, Sellers will be asked to remove birds from overcrowded display cages.
- 5. Poor quality and/or dirty cages will NOT be accepted.
- 6. All Birds must be presented in a good, health, weaned condition. Birds that are not will be asked to be removed from the venue.
- 7. All birds must be provided with sufficient food, water and a perch at all times and this the responsibility of the owner, All cages must have a solid base. However all wire finch cages must be covered on 3 sides and also the top.
- 8. Cages without a solid base will not be permitted.
- 9. Shell grit is not permitted within the venue due to hiring conditions.
- All cages for sale and display of birds must be suitable for stacking, as sellers may be required to stack cage should space became limited.
- 11. Birds will not be accepted for sale in carry boxes. Finches must still comply with item 7 above.
- 12. Sellers are responsible for selling their own birds and must have the relevant licences as required by the Department of Environment Climate Change and Water in the exchange of protected native species. Receipts of sale should be provided.
- 13. Sale ORGANISERS/OFFICIALS have the right to refuse entry of birds and trade stands and have the final word in any disputes that may arise.
- 14. Organisers bear NO responsibility for birds entered in the sale or left onsite on Saturday night.
- Admission fee for sellers is \$3.00ea, Helper \$3.00ea General Public \$4.00ea, Children under 12 free.
- 16. STRICTLY NO SMOKING WITHIN THE HIGH HALL OR SURROUNDS. NO EXCEPTIONS
- NO Poultry, Ducks, Domestic, Ornamental or Exhibition Pigeons and Pheasants will be permitted at the venue.
- 18. Birds sale CCBFA "CODE OF PRACTICE" is in force at the sale in conjunction SAS Sale Rules.
- Trade stand holder MUST provide a COPY of their Certificate of Currency for PUBLIC LIABILITY INSURANCE or they will be refused entry. This this a VENUE REQUIREMENT.
- 20. All accidents are to be reported to club officials in writing, for recording and investigation within 12 hours of the incident.
- 21. Bird Catching/Transfer stations are provided and use of these is strongly encouraged.
